AIR/NCAIR Co-hosted IPEDS Workshop



The Association for Institutional Research (AIR) and the North Carolina Association for Institutional Research (NCAIR) are co-hosting a one-day IPEDS Workshop for data providers and users in conjunction with NCAIR's Conference. Financial support for this workshop is provided by the National Center for Education Statistics (NCES).

This workshop features these training modules:

IPEDS Data as the Public Face of an Institution- This module raises the level of awareness among higher education professionals about the importance of accuracy and consistency in data reported to IPEDS. Examples of real IPEDS data used in the public domain will be incorporated, enabling participants to understand how IPEDS data are used by governmental and non-governmental entities. This module includes presentations, discussions, exercises and demonstrations utilizing IPEDS data tools and resources. Topics include:

- Data sources (within IPEDS surveys)
- IPEDS lifecycle
- Public and institutional use of IPEDS data
- Data nuances and context for interpreting the data

IPEDS Data and Benchmarking: Supporting Decision Making and Institutional Effectiveness-Module 1 introduces the fundamentals of creating benchmarks to measure institutional effectiveness. The module provides an overview of the types of comparison groups that can be constructed using IPEDS data, with examples of appropriate use. Participants will use actual data from the IPEDS surveys, including the IPEDS Data Feedback Report and Executive Peer Tool. Exercises and resources will demonstrate processes to establish key performance indicators and identify variables to refine comparison groups.

Title: Academic Confidence and the Impact of a Living-Learning

Community on Persistence

Academic confidence cultivated within the context of learning communities may be a major key to student success. While learning communities (LCs) date back to the 1920s as a method of improving the quality of the undergraduate experience, little if any work has been done in estimating their effectiveness relative to students not in LCs. This study demonstrates clearly that in spite of budgetary constraints, even within modest learning community models, students show more positive outcomes (first year GPA and persistence to year two) than non-learning community students. The statistical power of structural equation modeling is demonstrated. Policy implications are discussed.

Passage of the Higher Education Opportunity Act in 2008 has necessitated the collection of additional financial aid data within the Integrated Postsecondary Education Data System. Collection of these aid data affords for greater transparency of net price to students, but also permits policymakers the ability to more closely scrutinize price at the institutional level. This presentation will focus on issues related to the collection and use of financial aid data, including: 1) additional data being collected in the Student Financial Aid (SFA) survey component, 2) current and forthcoming uses of IPEDS aid data on College Navigator (including College Affordability Lists), and 3) requirements for the implementation of institutional Net Price Calculators.

In these days of budget cuts and limited resources and support staff, how does an IR office manage its data efficiently? There is an all too often overlooked, yet powerful and free tool right at our fingertips. Macros are a group of programmed instructions in the VBA (Visual Basic Applications) environment whose main purpose is to automate tasks and resolutions for complex calculations. They can be applied to a wide range of products within the Microsoft Office suite, as well as various other applications. We will demonstrate how to easily create macros in Microsoft Word, Excel, and Access using just your keyboard, mouse, and toolbar instead of programming commands. Macros can be especially beneficial to institutional researchers in small offices as they free up valuable time for other tasks.

The presenter will provide a specific example by demonstrating how a pivot table can be used to quickly calculate data formatted for the CUPA faculty salary by discipline study (average, maximum, and minimum salaries by discipline and rank) starting with a unit-record file.

Title: Non-Cognitive Factors Count: Retention Predictors using the BCSSE (Beginning College Survey of Student Engagement) Presenters: Mondrail Myrick, Fayetteville State University

The purpose of this research is to find early predictors of first year retention and to determine which students are more likely to drop out, using historical data. Data were collected from the Beginning College Survey of Student Engagement (BCSSE) and the Student Data File. Misclassification models, decision trees, and binary logistic regressions were used to determine predictors of retention. Students with higher first term GPA's and that stated on the BCSSE that they never or sometimes missed a day from high school were more likely to return for their second year of college.

When moving from paper- to web-based administration, the course evaluation system at NC State University (ClassEval) was redesigned to allow for tailoring to the specifications of college deans, department heads, and instructors. In addition to the university-wide questions asked on every evaluation, individual course evaluations may now include a combination of college-, department-, and course-level unique questions. The unique question process was piloted in the Spring of 2008 to a select group of colleges and departments. In each semester since then, all college deans, department heads, and instructors have been invited to participate in the process.
