NCAIR Summer Drive In at SAS Institute

NCAIR and SAS Institute joined in a "first of its kind" partnership on July 23, 2004, as over 30 NCAIR members met at SAS Institute in Cary, NC for the annual Summer Drive-in meeting. This was the first meeting at the corporate campus of an organization with no direct affiliation with SAS Institute. We thank Jerry Oglesby and Susan Walsh from SAS for their strong commitment to SAS in Higher Education and Institutional Research. Four presenters from SAS Institute provided us with valuable information on SAS products.

Enterprise Guide is an integrated suite of software products that can be used to access the power of SAS without learning the SAS programming language or to create new code or modify existing programs. It provides an interface to the strength of the underlying SAS modules using drag-and-drop functionality.

SAS/STAT for Version 9 brings additional analysis tools for use with surveys and more robust regression procedures.

The Output Delivery System (ODS) provides a method of easily delivering output from SAS procedures to a variety of formats with greater flexibility. With ODS, output can be customized in both appearance and content. It is especially useful for the creation of those web pages so critical to Institutional Research.

A demonstration of using SQL (Structured Query Language) to access data in a data warehouse provided us with new insights into sub-setting and reporting on the massive quantities of data we handle as institutional researchers.

In addition to the excellent presentations by Susan Walsh, Phil Gibbs, Davetta Dunlap, and Kathy Kiraly of SAS Institute, we were treated to an excellent lunch in the SAS customer cafeteria and had the opportunity to walk around the grounds of their beautiful campus.

Dr. Randy L. Swing is Co-Director & Senior Scholar for the Policy Center on the First Year of College. The Center's signature project, Foundations of ExcellenceTM, is an aspirational and measurement model for the first college year developed with input from over 200 colleges and universities. His recent research and writing includes case studies of institutions of excellence in the first year (in the forthcoming from Jossey-Bass – *Achieving and Sustaining Excellence in the First College Year*), institutional assessment (in the forthcoming from Jossey Bass – *Challenging and Supporting the First-Year Student*), and benchmarking first-year seminar outcomes. He is a fellow at the National Resource Center on The First-Year Experience where he produced two monographs on first-year assessment (*Proving and Improving* – Vol I & II). His work at the Policy Center includes founding the First-Year Assessment Listserv (over 1,000 subscribers), developing the First-Year Summer Assessment Institute, and helping to establish

the *Your First College Year* (YFCY) survey and the *First-Year Initiative* (FYI) benchmarking survey. Randy is a frequent speaker at national and international conferences. He is a visiting professor at Kansi University of International Studies in Japan. For two decades prior to 1999, he held various leadership positions at Appalachian State University in assessment, advising, Upward Bound, and first-year seminar. He holds a Ph.D in higher education from the University of Georgia, MA and EdS in Counseling from Appalachian State University, BA in Psychology from the University of North Carolina – Charlotte and attended Davidson County Community College.

Robert F. Vagt



Robert F. Vagt is the sixteenth president of Davidson College, and has served as president since July 1, 1997. Mr. Vagt received a B.A. in Psychology from Davidson in 1969, and a Masters of Divinity from Duke University in 1972. He was ordained to the ministry in 1972 by Concord Presbytery, the same presbytery that founded Davidson College in 1837. His early career included working as a warden with the North Carolina Department of Corrections and directing clinical programs and services at Northwest Alabama Mental Health Center. In 1974 he was appointed Deputy Commissioner of Corrections for the Commonwealth of Massachusetts. He joined the New York State Division of the Budget as Assistant Director in 1975 where he helped form the Municipal Assistance Corporation, later serving as its Executive Director. He worked for three international oil and gas exploration and production companies from 1980 to 1997, as President and COO of Adobe Resources; as Chairman, President and CEO of Global Natural Resources; and as President

and Chief Operating Officer of Seagull Energy Corporation. He currently serves on the boards of Lake Norman Regional Medical Center, Children's Defense Fund, North Carolina Progress Board, and Cornell Companies, Inc. Mr. Vagt and his wife have two daughters.

To submit a Proposal:

- (1) Prepare a **Proposal Cover Sheet**. Use the form in this newsletter or prepare an equivalent document containing all information specified in the attached form.
- (2) Prepare a **Presentation Abstract** of 100 300 words, double-spaced, 12-point type. The closer to 100 words the better, as the abstract for all accepted proposals will be used for the conference program. Be sure to include the session title as it should appear in the Abstract. **DO NOT INCLUDE PRESENTER NAMES OR INSTITUTIONS IN THE ABSTRACT**.
- (3) E-mail or snail mail your proposal (E-mail is strongly preferred).

To submit via e-mail, create a message entitled "2005 NCAIR Conference Proposal" and attach the Proposal Cover Sheet **and** the abstract as one document. The attachment must be in Microsoft Word (preferred), WordPerfect, or text file format. Send to kendrick.tatum@duke.edu.

Responsibilities: Lead efforts to coordinate and improve assessment activities distributed across the university. Lead focused, university-level assessment activities. Facilitate collection, analysis, and interpretation of assessment results; ensure that results are used effectively for program improvement, planning, and policy-making. Assist undergraduate, graduate, and administrative assessment professionals across campus as needed. Advise institutional research and planning colleagues on campus data needs and research design.

NCAIR Executive Committee Minutes, 7-23-2004 Summer Drive-in at SAS Campus -- Cary, NC

Attendance: Anne Marie Bellamy, Laura Boyles, Carol Gosselin, Michael Hadley, Brian Rolfe, Alton Rucker, Adam Shick, Rob Springer, Kendrick Tatum

Meeting called to order by President Anne Marie Bellamy.

Old/New Business:

1. Planning Committee

a. Laura Boyles reviewed Planning Committee work ("Summary of Planning Committee Work" and "2005 Conference Planning Committee Membership" documents entered into Secretary's notes). Laura proposed that Vendor, Travel Grant, and Mentor/Newcomer committees be stand-alone committees, rather than being governed by the conference Planning Committee. These committees will then have continuity from one conference to the next.

2. Vendor Committee

- a. Rob Springer gave Vendor Committee update. Vendor contribution structure was discussed. Details can be reviewed in the hard copy of this report which is entered into Secretary's notes.
- b. Placement of vendor's logos on NCAIR website was discussed.
- c. Vendor Committee proposal was approved.

3. Conference Planning

- a. Laura Boyles proposed that planning occur two years out, so that during a given conference, information for the following year's conference can be disseminated.
- b. Michael Hadley suggested a rotation of location: western/central/eastern.
- c. Rob Springer indicated that the joint meeting with SCAIR must mesh with the western/central/eastern rotation.

4. Travel Grants.

- a. "Summer Drive-In Travel Grant Committee Summary June 2004" and "Priorities for funding opportunities are as follows" documents are entered into Secretary's notes.
- b. Michael Hadley questioned the prioritization of travel grant funding opportunities in particular, grants to present at the SAIR conference and the availability of travel grants to non-members.
- c. Rob Springer suggested waiving registration fee in addition to the \$200 travel grant to attend annual NCAIR conference. It is agreed that the registration fee should be waived, and the travel grant policy will be modified accordingly.
- d. It is agreed that the travel grant program as proposed (including the modification described in item 4-c) will be "piloted" for one year.
- 5. Michael Hadley presented the treasurer's report (entered into Secretary's notes).

President Anne Marie Bellamy adjourned the meeting.
