# PRESIDENT'S CORNER - Paul Nagy

For those of you who do not know, it is with sorrow that I announce the death of Dr. Brooks Cates in November of 1998. Brooks served as Director of Institutional Research at Elon College for many years. He was a stalwart supporter of NCAIR, serving as treasurer on the Executive Committee and facilitator of a very successful 1995 summer drive-in at Elon College. I also had the pleasure of working with Brooks on the Technical Committee of the Commission on Higher Education Facilities at UNC-GA. His dedication, deportment, and thoughtful manner are a continuing inspiration to us all.

Shortly before Brook's death, on November 16, 1998 the Executive Committee adopted a motion to bestow Honorary Life Membership to him. This is the award authorized by the Association's constitution and bylaws for recognition of exemplary service to NCAIR. The award plaque was given as a remembrance to Brook's wife, Nicole, who frequently joined Brooks at the annual conferences.

I would like to express thanks and appreciation to Nerissa Rivera and Robert Ussery, co-editors of the 25th Anniversary Conference Proceedings. The central component of the proceedings was the complete inclusion of the 1998 Best Paper as authored by Xiaoyun Yang and J. Keith Brown of the N.C. Department of Community Colleges. Additionally, a number of listings were included, such as the charter membership, that will prove useful for archival purposes. Also, many thanks to Renee Jarvis, of East Carolina University, for the cover design. These graphics served as a motif for all publications related to the 25th Anniversary Conference.

It would be a disservice to the membership if I did not share with you my evaluation of the 1999 NCAIR/SCAIR Conference site - the Wyndham Myrtle Beach Resort in Myrtle Beach, SC. This is a class act! I was surprised and impressed. The resort includes an on-site golf course, tennis courts, heated outdoor pool (I now challenge someone to swim in February!), and exercise room. #### CHANGES TO THE CONSTITUTION AND BY-LAWS

At the business meeting of the 1998 25th Anniversary Conference in New Bern, NC three modifications to the Association's Constitution and By-Laws were approved by the membership. These changes have been incorporated within the documents as found on the NCAIR web site. The modifications are as follows:

Changes to the Constitution: Article IV. Section 2. Duties of Officers

- 1. Secretary Delete (a) (keep and publish annually an accurate listing of the members of the Association, and provide a list of active members during the Annual Conference). Change (b) to (a).
- 2. Treasurer Delete (e) and replace with the following language:
- (e) provide to the chair of the membership committee regular reports of changes in the current membership of the Association, and the names and addresses of any new members.

Changes to the By-Laws: Article IV, Section 4. Membership Committee

3. Add to the end of the section: The chair of the membership committee shall keep and publish annually an accurate listing of the members of the Association, and provide a list of active members during the Annual Conference.
