WORKSHOP

The Association for Institutional Research (<u>AIR</u>) and the North Carolina Association for Institutional Research (<u>NCAIR</u>) are cohosting a one-day IPEDS Workshop for data providers and users in conjunction with <u>NCAIR's Conference</u>. Financial support for this workshop is provided by the National Center for Education Statistics (<u>NCES</u>).

IPEDS Workshop Highlights

- Workshop scheduled in conjunction with <u>NCAIR's Conference</u> March 15, 2010
- Taught by experienced practitioners from across the country
- Includes six hours of instruction, workshop materials, breaks, and lunch
- No tuition charge to participants
- Travel assistance awards are available

This workshop is comprised of two modules:

1) IPEDS Data as the Public Face of an Institution- This module raises the level of awareness among higher education professionals about the importance of accuracy and consistency in data reported to IPEDS. Examples of real IPEDS data used in the public domain will be incorporated, enabling participants to understand how IPEDS data are used by governmental and non-governmental entities. This module includes presentations, discussions, exercises and demonstrations utilizing IPEDS data tools and resources. Topics include:

- Data sources (within IPEDS surveys)
- IPEDS lifecycle
- Public and institutional use of IPEDS data
- Data nuances and context for interpreting the data

2) IPEDS Data and Benchmarking: Supporting Decision Making and Institutional Effectiveness- Module 1 introduces the fundamentals of creating benchmarks to measure institutional effectiveness. The module provides an overview of the types of comparison groups that can be constructed using IPEDS data, with examples of appropriate use. Participants will use actual data from the IPEDS surveys, including the IPEDS Data Feedback Report and Executive Peer Tool. Exercises and resources will demonstrate processes to establish key performance indicators and identify variables to refine comparison groups.

Monday Evening Opening Speaker: Dr. Randy Swing



Dr. Randy Swing is the Executive Director of the Association for Institutional Research, a professional association of 4,200 members. Until 2007, Swing served as Co-Director & Senior Scholar at the Policy Center on the First Year of College, a Fellow in the National Resource Center for The First-Year Experience, and held appointments in Japan and Scotland. He is a frequent speaker at conferences and author on assessment, institutional research, and student success. Prior to 1999, he held leadership positions at Appalachian State University in assessment, advising, Upward Bound, and Freshman Seminar. He holds a Ph.D. from the University of Georgia.

Dr. Alan Mabe serves as the Senior Vice-President for Academic Affairs for the University of North Carolina System. A member of the Florida State faculty from 1972-2002, Mabe chaired the philosophy department for 15 years until 1993, when he assumed the position of dean of graduate studies. A past president of the Faculty Senate, he assumed the dual title of associate vice president for academic affairs at FSU in 1998. He came to the UNC system in January 2002. Mabe holds an undergraduate degree in Philosophy from Guilford College and earned master's and doctoral degrees from Syracuse University.

NCAIR Travel Grant Program

The North Carolina Association for Institutional Research (NCAIR) has a travel grant program to assist members with attending the annual conference.

<u>Purpose:</u> To promote professional development among institutional research professionals that work in institutions and organizations from North Carolina associated with NCAIR.

<u>Eligibility:</u> Travel/development grants are available to both active members and newcomers (individuals who will become new members of NCAIR at the next annual conference) from North Carolina schools. Upon review of the applications by the Travel/Development Grant Committee, a recommendation is made to the NCAIR Board of Directors who will approve the travel/development grant awards.

<u>Amount of Grants:</u> The amount awarded to each grant recipient will be based on the amount requested as well as the financial need of the requester, but will not exceed \$200. The grant can be used toward hotel and mileage. *Conference registration fees will be waived for recipients*.

<u>Application Materials and Considerations:</u> To be considered for the award, application materials must be submitted to the Travel Grant Committee. The deadline for grant application will be February 3. The following items must be submitted:

- a. A completed NCAIR Travel Grant Request Form.
- b. A brief resume/curriculum vita.

<u>Criteria for Awarding of Grants:</u> Recommendations by the Travel Grant Committee to the Executive Committee for travel grant awards will be based on information submitted in the application materials.
